Professional Photography Policies and Rules

Cruise in Trees Christmas Tree Farm welcomes photography on the farm. However, as a private business and personal property, any and all professional or amateur, non-commercial photographers and their clients must understand and adhere to the following policies and rules. These policies and rules have been established to allow an enjoyable experience for all our guests.

Professional Photography Start and End Dates:

- Professional photography is only allowed before Thanksgiving and after Christmas.
- No sessions during operating hours will be allowed.

Photographer Policy Responsibilities

- Photographers must request permission before setting any client dates or arriving at the farm. We reserve to refuse permission and access to the Farm.
- Photographer must sign Liability Waiver and application/fee prior to the photography session.
- Photographer must communicate policy rules to their clients prior to the photo session.
- Photographers without permission, and in violation of any part of policy, of will be asked to leave immediately.

Location Site Usage Fee/Payment:

- \$40 for 2 hour session per day, Additional \$40.00 for over 2 hours per day. (We only accept Cash or Check).
- Payment is required at scheduling time to secure schedule slot
- All pictures shared on Social media will be tagged with location.
- Permission is given on a single-day basis. Please complete a separate application for additional days.

Photographer Policy Rules

- Parking:
 1. Photographers must first check in at main house, turning in form and session fee if not already mailed in.
 2. Parking allowed only in the main parking lot. Absolutely no vehicles are allowed in the fields at any time.
- No smoking
- Owner must know your location at all times, for safety of clients. The tree farm is a large acreage with hidden drop-offs and other safety hazards.
- Children must be supervised by parents at all times
- There are no public restrooms available for use
- Animals must be on a leash, waste clean up and disposed
